>>> GROCERY CHAIN ADMITS LIABILITY FOR SLIP AND FALL

Shortly before his 60th birthday, John Doe was seriously injured when he slipped and fell on a wet floor in the produce section of a grocery store. He hired Tamaki Law to investigate his accident. His attorneys demanded sweep logs from the store and found that the store failed to conduct routine floor inspections to discover hazards like spills and leaks in the produce department. Former employees of the store, including the produce manager on duty at the time of

John's fall, also testified about the lack of safety training and the store's poor condition, as well as produce misters that sprayed water on the floor, causing it to become slippery. Just before trial, the case settled for \$1,000,000, one of the highest (if not the highest) settlements in a slip and fall case in Eastern Washington.
