>>> FAMILY'S NIGHTMARE TRIP ENDS IN JUSTICE

While on a cross-country trip from Pennsylvania to the Redwoods Forest in California, the Doe Family traveled through the Tri-Cities when they encountered a sudden snowstorm on I-82 south of Kennewick. The family of four pulled to the side of the road as white-out conditions began to form. They could see and hear other vehicles colliding around them when they were violently struck by another vehicle.

The collision caused severe injuries to each family member, and after finally being discharged from the hospital and returning to

Pennsylvania, the family contacted Tamaki Law to investigate. The family did not know who hit them, and the police report indicated that more than a dozen vehicles were involved in multiple collisions, but it was unclear who had hit the family vehicle.

After months of investigation, including reviewing 911 calls, interviewing dozens of witnesses, and talking to emergency responders, we learned that a tow truck responding to an earlier collision was driving too fast for conditions and smashed into the family vehicle.

Despite that evidence, the tow truck denied liability, and Tamaki Law filed suit against it and eight other drivers suspected of contributing to the collision. After years of litigation, the case settled for more than \$1,500,000, which was the collective insurance policy limits of all defendants.
