>>> CLIENT VICTORY: \$1.3 MILLION SETTLEMENT IN CHILDHOOD SEXUAL ABUSE CASE

Tamaki Law recently secured a \$1.3 million settlement on behalf of a young woman who was sexually abused as a child by a trusted adult. The abuse occurred while she was visiting a friend's home, where adults responsible for her safety failed to protect her.

Our client bravely came forward years later, initiating a criminal investigation that led to a conviction. We then pursued civil justice, filing a lawsuit that held all responsible parties accountable for the pain and trauma she endured.

While no amount of money can undo what happened, the settlement provides critical support for her healing and future. We are proud to have helped her find a measure of justice and to share her story (anonymously) as a reminder of the strength survivors carry and the importance of standing with them.

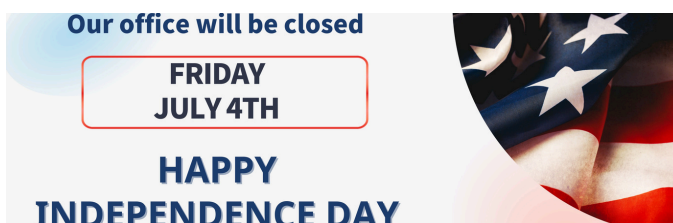
